

LOCAL PLAN – UPDATE

- 1. We are getting close to the start of the Regulation 18 consultation. There are currently discussions happening at TMBC as to what this might look like, given most of the evidence underpinning the Local Plan has now been completed. To meet the key December 2026 deadline for final submission to the Planning Inspectorate, it is vital this consultation takes place. Your preparations need to cater for this.
- 2. A key parish document to have up to date and to raise during the consultation where appropriate is the Parish Capital Plan.


DEVOLUTION

- 3. On Wednesday 3 September, Kent's councils asked its advisors KPMG, whose work is being paid for by the government, to look in more detail at two options for unitary councils and the areas they should cover. These are options 3a and 4b as below. You will note they have the same geography for us combining the boroughs of Tonbridge and Malling, Maidstone, Sevenoaks and Tunbridge Wells.
- 4. Once KPMG and council officers have worked together to draw up business cases for each of the options, each council will go through its own decision-making process to decide which option it supports. Business plans need to be submitted to the Ministry of Housing, Communities and Local Government by 28 November. The final decision rests with ministers.
- 5. Kent County Council, which prefers one Council covering the whole of Kent and Medway, has effectively withdrawn from this work after its preferred model was not shortlisted on 3 September and is putting forward its own submission.

A229 BLUE BELL HILL ROAD REPAIRS

8. Though a KCC matter, you should note the extensive road works going into the A2229 on Blue Bell Hill in the coming months. Your clerk will be aware of this work. TMBC are checking the extent of this work at present, to see if it affects any of our operations.

9. There does seem to be a mass of traffic moving through Burham with long convoys early in the morning and conflicting with the school bus runs.

PLANNING APPLICATIONS UPDATE

- 10. Your Clerk has asked for an update on the planning applications below;.
- 11. TM/22/02377/FL: Land southwest of junction of Common Rd and Chatham Road: Erection of 3 x four-bedroom detached houses with associated access, parking, landscaping, bicycle, and refuse store. The case officer has finished his report on this and recommended approval. We can see no planning reasons for any further delay and therefore accept that decision. We await promulgation after further TMBC checks.
- 12. TM/24/02089: Burham Water Works: Installation of three equipment kiosks. There has been a delay waiting for BNG information. This has been received and a decision is imminent.
- 13. TM/24/02043: 486 Common Rd, Chatham: This development was for an Annex. However the Annex was larger than the building. As such the application was inappropriate and the applicant has to submit a planning application for a building that is required to meet different criteria to the present application.
- 14. TM/25/00132: Lawful development certificate proposed: 5 Haleys Place. Remove existing garage and rebuild closer the property. This application has been withdrawn as the proposed development is in front of the building line and as such does not meet the requirements for permitted development.
- 15. TM/25/00506/PA: 235 Rochester Rd, Burham: New single storey residential dwelling. We have had no update on this application but hope to have one in time for your meeting.

MR17 Closure

16. Kent County Council has made an Order, the effect of which is to temporarily close Public Footpath MR17 between New Court Road and Old Church Road from 22 September 2025. The path will be closed for a maximum of six months, although it is expected that it will reopen 31 October 2025. The path is closed because of repairs to the embankment.

ENFORCEMENT ACTIONS IN PROGRESS

17. There has been no change in any of the Enforcement action we have been reporting to you.
